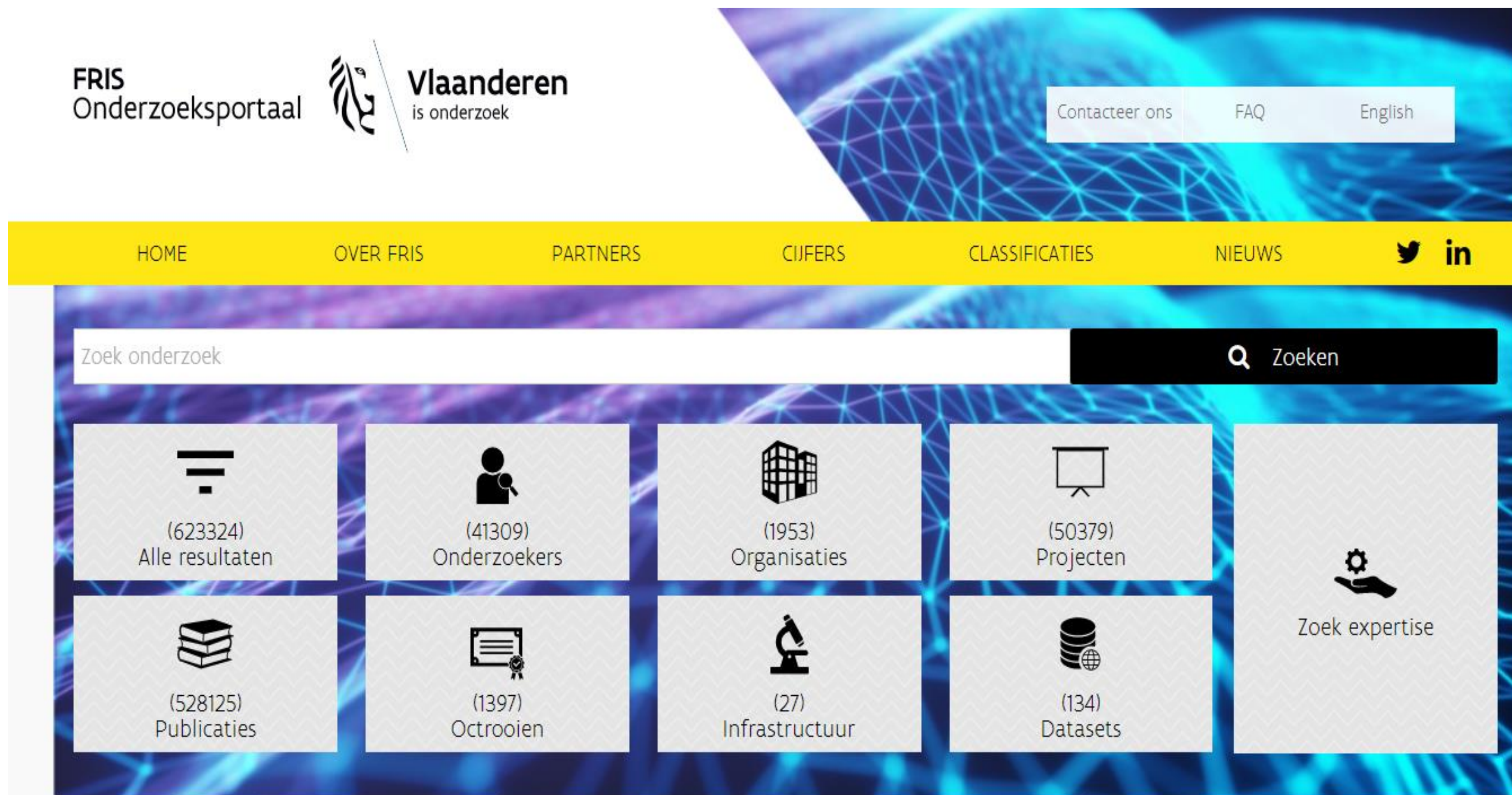

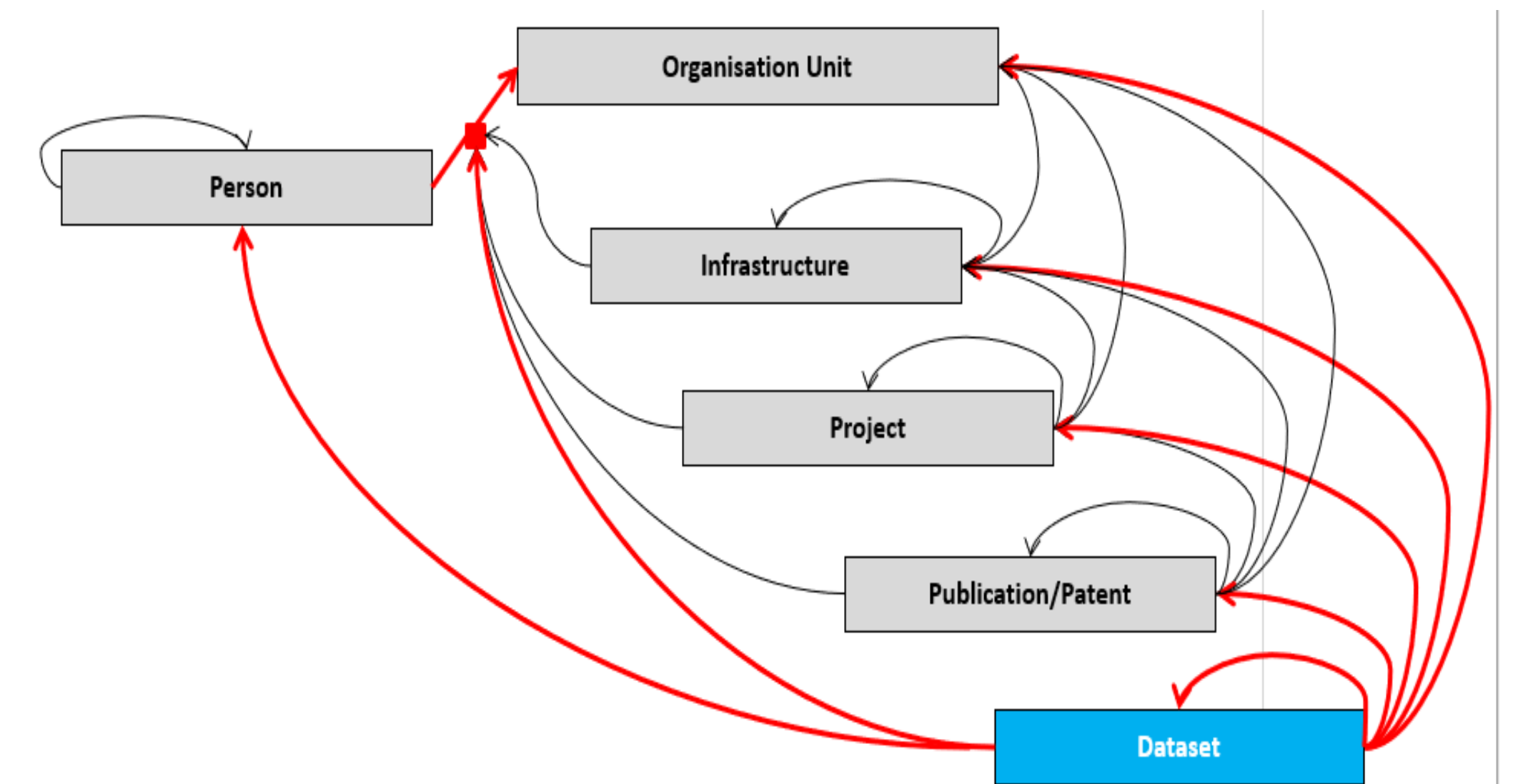

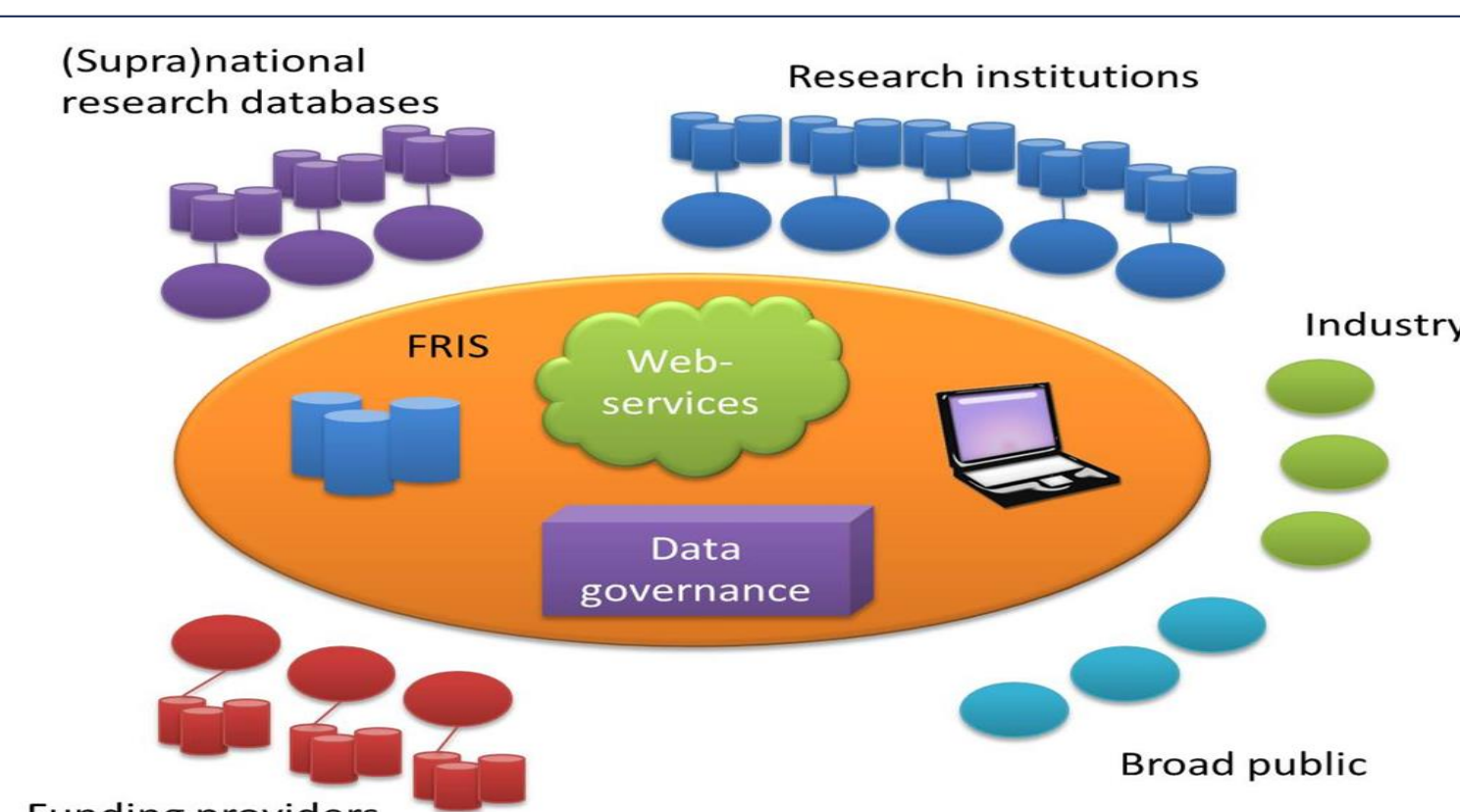
Open data KPI

- Open = Access rights = 'open' or 'embargoed' + 'open' license <https://opendefinition.org/licenses/>
- Standardized delivery: <https://spdx.org/licenses/>
- Metadata fields to monitor open data KPI: PID, Access rights, Licenses, Legitimate opt-out, Link to project & Link to publication

FAIR data KPI

- Metadata property 'FAIR data label': in progress
 - Options:
 - a. Minimal metadata provided = FAIR
 - b. F-UJI score
 - c. FAIR self-assessment score
- => Align with EOSC: TF FAIR Metrics & Data quality
