Role ambiguity


- Practice - theory

- Function, role, task and competence







The problem now is that it is such a wide spread landscape and everyone is working alongside each other.' (Participant 12)




Terug naar werk coordinator (mutuality)

Clarifying concepts


- Disability Case Management – coaching,
